Fall of WCPA, Provisional World Parliament & Provisional Earth Federation – A Textbook case of the Incompetent Leadership, Social Climbing & Machiavellian Tactics

As per By-Laws of the World Constitution and Parliament Association (Approved by votes on 2/27/18) and registered with Colorado Secretary of State Date and Time: 03/03/2018 12:26 PM ID Number: 19901022686 Document number: 20181191558:

Article 2.1 WCPA was formed to establish a self-governing democratic world federal republic as a constitutionally limited global government through the adoption of a world constitution known as the Constitution for the Federation of Earth.

1. Irresponsible moves made by the commissions:

19.2.03. After six months, in those countries where national governments have not responded favorable to the ratification call, the Ratification Commission and the World Elections Commission may proceed jointly to accomplish both the ratification of the World Constitution by direct popular referendum and concurrently the election of Members of the World Parliament.

The effectiveness and prevalence of direct popular referendums can vary by country and region, as different political systems have different mechanisms for involving citizens in decision-making processes. The wording "may proceed" was used in the constitution for this reason. By not evaluating the laws and regulations of countries and directly assigning authority to people (who don't even ratifying the constitution) from different countries to mobilize people to form a district of a provisional government other than that of their own country, the commission currently in action puts them at high risk of being subject to treason against the state and government. This was a very irresponsible and dangerous move. The selection process of the commission was also highly irresponsible. Individuals were assigned numbers based on their interests without considering their social, political and legal understanding. Additionally, the fact that a person has experience related to the field, as well as knowledge of the laws, rules, and regulations of their respective countries, was not taken into account.

2. Overlapping, Hostile Takeover and Financially illegal actions:

Following the passing of Dr. Terence P. Amerasinghe on June 1, 2007, the position of President of the World Constitution and Parliament Association (WCPA) remained vacant for four and a half years, until December 12, 2012. During this time, Glen Martin continued to serve as Secretary General.

From 2007 onward, no annual reports were filed for WCPA with the Colorado Secretary of State, despite the organization being incorporated and registered since 1990. This failure to comply with local regulations resulted in WCPA being declared delinquent by the Colorado Secretary of State in late 2013.

In contrast, Glen Martin continued to file annual reports for the Institute on World Problems, an educational charity established by Dr. Amerasinghe to focus on "education concerning world problems" and "education concerning the governance of individuals". Although Martin utilized the WCPA name extensively for activities related to the Provisional World Government and its agencies, the funds being used for these purposes came from the Institute on World Problems.

Furthermore, funds from the 501(c)(3) organization were solely allocated to activities of the 501(c) (4) entity. The Institute was not fulfilling its educational mission; rather, it was conducting WCPA activities. Additionally, the name of the Institute was changed to the Earth Federation Institute (2019) and subsequently to the Earth Constitution Institute (2020), ostensibly to establish a connection to the Earth Federation and the Constitution. A figurehead treasurer, who is Glen Martin's wife, was also appointed for WCPA to create an appearance of legitimacy, despite the organization having no bank account and no funds. He continues to openly solicit funds for entities related to the Provisional World Government (Earth Federation), such as the Provisional World Parliament and World Districts, rather than for educational activities.

These actions constituted multiple violations, particularly of the Articles of Incorporation and Bylaws of both organizations, resulting in ultra vires acts and breaches of fiduciary duties, which can constitute grounds for a derivative suit. Furthermore, the WCPA bylaws were amended to enable authoritarian control, allowing the President to be elected for a term of ten years instead of annually.

- **3. Failed to establish any organizations created by the PWP:** WCPA's other primary directive was to facilitate, coordinate, record and promote the work of the Provisional World Parliament and its Standing Parliamentary Commissions. But Failed, so many commissions and organizations were created but nothing was established or were closed down in past decade and half.
- **4. "No Bank account" worse then Bankrupt:** By not even maintaining the Bank account for WCPA for decade and half, WCPA has raised concerns regarding it's own Operational Efficiency, Credibility, Trust and Legal Compliance. In the United States, there are legal requirements and regulations governing nonprofit organizations, including the necessity for proper financial management. Maintaining a bank account is often a legal requirement, and failure to comply with these regulations can result in legal consequences for the board of trustees. This could result in penalties or other legal consequences for the board of trustees. But not doing so he has put all the board of trustees subject to the legal consequences.
- **5.** No funds and financial irregularities: The biggest failure of WCPA leadership came to light multiple times when he, personally, along with the person hired (and paid) for fundraising, failed to get a single cent, not even a dollar, from all the contacts he so proudly claims to be working with for the so-called gala online fundraising events for the launch of world districts. Furthermore, world districts was a commission-based effort for which ECI was soliciting money, another overlapping and financially illegal action.

And over the years lot of transactions were done to buy stuff for WCPA and approved by Glen as President of the ECI.

All of this puts all the board of trustees subject to the legal consequences in ECI or WCPA.

- **6.** No quorum in the meetings: We observed that, during the meetings, the quorum was determined by counting the number of people present in the call, rather than considering the actual number of board members required for any decision. According to the by-laws of the WCPA, the board should consist of not fewer than fifteen (15) members and a quorum is a majority of the number of Trustees serving at the time of the meeting, which does not appear to be the case.
- **7. Not international and No Parliament anymore:** In one of the meetings, we liked Justice David Percy Quispe Salsavilca's question, he asked, "Why are there so many Indians only?" It is another issue, as International PWP is no longer a transitional international legislative body but has been turned into an event in India. Rules regarding who can be in PWP are very clear in Article 19.3:

- 19.3.1. The Provisional World Parliament shall be composed of the following members:
- 19.3.1.1. All those who were accredited as delegates to the 1977 and 1991 Sessions of the World Constituent Assembly, as well as to any previous Session of the Provisional World Parliament, and who re-confirm their support for the Constitution for the Federation of Earth, as amended. 19.3.1.2. Persons who obtain the required number of signatures on election petitions, or who are designated by Non-Governmental Organizations which adopt approved resolutions for this purpose, or who are otherwise accredited according to terms specified in Calls which may be issued to convene particular sessions of the Provisional World Parliament.
- 19.3.1.3. Members of the World Parliament to the House of Peoples who are elected from World Electoral and Administrative Districts up to the time of convening the Provisional World Parliament. Members of the World Parliament elected to the House of Peoples may continue to be added to the Provisional World Parliament until the first operative stage of World Government is reached.
- 19.3.1.4. Members of the World Parliament to the House of Nations who are elected by national legislatures or appointed by national governments up to the time of convening the Provisional World Parliament. Members of the World Parliament to the House of Nations may continue to be added to the Provisional World Parliament until the first operative stage of World Government is reached.
- 19.3.1.5. Those universities and colleges which have ratified the World Constitution may nominate persons to serve as Members of the World Parliament to the House of Counsellors. The House of Peoples and House of Nations together may then elect from such nominees up to fifty Members of the World Parliament to serve in the House of Counsellors of the Provisional World Government.

In recent years, people participating are merely curious and not even aware of what's going on. Generally, they are individuals associated with the organizer or sponsor of the event and PWP. They are not even familiar with international laws or the constitution or bills or acts. In front of them, these PWP WLAs have been passed without proper constitutional PWP members, as explained in Article 19.3.1.

Thanks to the covid and webinar boom, in Dec 2021 people showed up for the "International Convention (https://www.youtube.com/@pcti_cftedu/streams)" not "PWP".

- **8.** No list of Ratifiers: If you ask for a list of people who ratified the constitution, all they can produce is the scanned copy of the ratifiers from the year 1991. Additionally, they considers the list of email sign-ups and world citizen sign-ups at earthconstitution.world as ratifications. The most crucial aspect of the entire movement, which is how many people have actually ratified, is not available or maintained. It's just bizarre to grasp.
- **9.** No active constitutional lawyer or international lawyer: The entire organization revolves around the world constitution and international law. The ironic and disheartening reality is that WCPA don't have a single constitutional lawyer or international lawyer in the entire organization who is truly present there or ensures that things proceed as stated in the constitution.
- **10. Technologically challenged:** Let us start by definition of the CTO: The Chief Technology Officer (CTO) in a non-governmental organization (NGO) typically holds a key leadership role focused on overseeing the organization's technology strategy, implementation, and management. general responsibilities

Engaging in unprofessional TikTok videos by the president of an international NGO negatively

impacts the organization's image. And engaging with non-professional podcast makers negativly impacts the image of the president of an international NGO and NGO as whole.

Excuses such as 'we are working on this' or 'we will work on this' must not be an escape goat for him, as he has been the leader for 20 years, the same number of years social media on the internet has existed. That proves how technologically challenged he is, along with the people he claims to be working with. Even today, after 20 years, he uses Philip Isely as an excuse for his incompetence, which must not be acceptable anymore.

- 11. No Documentation of any sort and Lost Archive: He refrains from engaging in any form of official documentation. And also around the year 2014, reportedly, when Jelica Eli Isely, the wife of Philip Isely, offered the archive, he declined, citing a lack of storage space. He never pursued the matter afterward. Storage space is not a problem in the USA, as self-storage, available for less than \$100 today, is a very popular option there. The archive of an international NGO with a history involving governments and prominent world figures is a critical resource for maintaining transparency, ensuring compliance, learning from the past, and strategically planning for the future. It safeguards the organization's legacy and enhances its credibility in the eyes of stakeholders.
- **12. Abandoned Grassroots movement:** Before the year 2003, there used to be thousands of member organizations (about 2,222) and individuals from countries all over the world as part of the Global Ratification and Elections Network (GREN)/Earth Federation Movement (EFM), which was abandoned and never attempted to reconnect. In the digital age, abandoning a grassroots movement like this was a very irresponsible move.
- 13. Deception and Means of social climbing: Proposals, such as establishing a secretariat to "appear legitimate," are merely attempts by some individuals to extract funds from a defunct/dead organization. In a world where all types of international organizations small or big are increasingly embracing a work-from-home culture and cutting costs by reducing office spaces, such suggestions lack practicality and displays how challenged organization has become: Attempts to display legitimacy through office fronts rather than genuine groundwork are very pathetic.

 Many individuals hold titles without making any significant contributions to the organization's growth. In numerous cases, names within the organization are merely for display, and the name of these individuals and their non-contributing tenure is being used to justify statements such as, 'He has been with us for a certain number of years.' However, when asked for a report, they have nothing to show.
- **14. Turned WCPA in a "echo chamber":** Glen has surrounded himself with handful of people who agree with or affirm opinions without challenging him. Even though prominent people of all sort has contacted and showed interest but he won't let anyone competent to get in as it's not good for his authoritarianism.
