The information provided may be shared with authorized local law enforcement agencies or designated third-party entities for verification purposes. Candidates may be required to furnish additional information or documentation during the review process. All submissions must be accurate, complete, and truthful.

False, misleading, or incomplete declarations may result in disqualification, legal penalties, or invalidation of candidacy. Candidates will be formally notified in writing of the acceptance or rejection of their petition by the World Election Commission. Upon acceptance, candidate details will be forwarded to the Secretary of Parliament for further necessary action. By submitting this petition, the candidate acknowledges and agrees to abide by these terms and conditions.
